Reviewed printout of Dashboard printout including last three school years Suspension rates continue to decrease each year Only two years of data for Aspirations Advocates (which are the highest need for intervention) Currently on track to reduce total number of suspensions for this school year About 1/3 of referrals from this school year are non-education code referrals Top 3 offenses are fighting, obscenity and being under the influence or possession Highest numbers of both suspensions and referrals were male students Effective in reducing number of students suspended Academically appropriately placed student Staff training DII Mental health supports Access to alternative placement Next steps AVP reviewing specific students Admin team reviewing interventions (CAT/ACS, Aspirations Advocates, etc.) Hayley D. - Question regarding detention being included Teachers can use a referral and/or assign detention Diane B. - noted majority of discipline is freshmen and sophomore year and discussed possible reasons for this

- Diane B. reviewed letter written from Admin team to SDMC members
- Only 5 teachers who have 8 or more requests for recommendation letters
- Feedback
 - Jessie M why no Mondays and Fridays
 - o Donna A students need to give teachers time to complete letters
 - Diane M holidays excluded?
 - Diane B IVP reviewing google calendar will catch this
 - Chris C is one hour per student needed; could better letters be written in more time

- Leslie W two hours would not make a better letter; depends on teacher's knowledge of student; an hour adequate
- Cara K letter of recommendation never takes longer than an hour
- Arlene K different schools require different letter content and may count different
 - Diane B counselors previously did not report this issue when asked about this very concern
- Donna A students should ask early and often are turning in requests later and later
- Matt S is the hour discussed in the letter compensation or release?
 - Diane B release day only
 - If less than 8 letters, administration is flexible to give full day
- Hayley D can release days be used at home after school?
 - Admin proposal is not for banking or paying extra duty, it is for release days
 - Denise H not very many teachers using this now

- Summary discussed
- Student generated
 - o Committee members from Leadership joined Aspirations Task Force

- Video and training to staff at Staff Meeting
- Feedback given was largely positive
 - o Students reported "simple but elegant"
